# **ACCMA Local Government Professional Management Certificate Program**

The ACCMA Certificate Program is designed to provide increased knowledge and skills for those in local government to master the complexities of the political, social, and economic environment of public administration. The program is composed of 5 courses and continuing education, which is available for participants in a hybrid, classroom/online, format. It is eligible for one CMC Experience or one MMC Professional Contribution Point per 6 education hours by the IIMC and CPE hours by the ASBPA.

# **Leadership & Effective Public Management (10 HRS)**

Organizational failures and successes are a function of positive managerial climates which nurture strong leaders and facilitate learning, adaption, and high performance. Therefore, it is important for everyone to understand and to reflect upon the topics of management and leadership, from the executive director to the frontline staff. To do so, this course provides participants with an overview of supervisory, managerial, and leadership principles in public organizations.

### Laws & Ethics for Public Management (10 HRS)

This course explores the ethical and legal responsibilities associated with managing in the public sector and within the State of Alabama. Participants will be introduced to core state ethics laws and rules, identify, and utilize key tools and practices to build and maintain high-performing ethical organizations. Class time will also be spent identifying ethical tensions from the field with opportunities to engage in problem solving.

### **Economic & Community Development (10 HRS)**

Participants will learn the importance of their positions as local government administrators in the planning, advancing, and marketing of their community. A variety of tools to accomplish these tasks will be explored with emphasis on actual Alabama-based examples. Topics include: strategic and comprehensive planning, community leadership, community engagement, technology and development, public-private partnerships, and community branding. Policy development and implementation will also be discussed.

# Human Resource Management & Staff Effectiveness (10 HRS)

This course is designed to provide an overview of important personnel, employment, and human resource issues and discussions of the ways in which the work place is affected. Current employment laws and how they impact personnel actions and processes will be addressed from the perspectives of both the employee and the supervisor.
