



AND CGMHS SERVICE AREA


ZIP CODES WITH OVER 100 DRUG RELATED DEATHS 2013 TO 2015

HOMICIDE VS. OVERDOSE DEATHS




2017 HOMICIDES BY LOCATION

2017 OVERDOSE DEATHS BY LOCATION


DRUG RELATED ARRESTS
